### Environmental Economics: Fishing the Winnebago Pool Lakes

As part of the week-long Earth Charter Community Summit, the Winnebago Lakes Council is sponsoring two talks and a panel discussion about the recently completed economic studies of the value of angling on our lakes. Keynote speaker, resource economist Dr. John Stoll of UW Green Bay, will be joined on a panel by representatives from government, business, and conservation interests.

The theme of the Earth Charter Community Summit is local and global sustainability. Another event of interest during the week will be a presentation on Wednesday evening, October 11, by author, attorney and corporate philosopher, David Korten, founder of YES! magazine. # **Around the Lakes**

Two new educational and data collection projects are aimed at helping citizens protect the ecological health of the Winnebago system.

### Clean Boats, Clean Waters

Student interns from UW Oshkosh contacted 2,051 people and inspected 1,669 boats during the first summer of the Clean Boats, Clean Waters program on the Winnebago lakes. Following advice of the Wisconsin DNR and county parks staff, they spent most of their time at busiest boat launches on busy weekends. They also worked at boat launches in days leading up to fishing tournaments, which tend to attract boaters from outside our region.

The main goal of the interns was to educate boaters about how they can prevent the spread of invasive species from lake to lake. They also collect data on vehicle license (in-state or out), type of boat, engine size, whether boats entered or left the lake with vegetation on them, last water body visited, whether they followed prevention steps, and prior knowledge of invasive species. This will provide us with a lot of data to analyze over the winter, but here are a few statistics we have now:

#### **Critical Habitat Identification**

Wisconsin DNR fisheries, wildlife and water resource biologists have identified critical habitat features on lakes Winnebago, Poygan, Butte des Morts and Winneconne. These include near shore areas important for fish spawning, brood rearing, water pollution filtration, critical "places of living" for fish and wildlife, unique physical features, and shore areas with outstanding natural qualities. Most often these are areas with abundant aquatic and wetland plants.

The critical habitats are mapped for future reference, allowing improved review of proposals for marina development, aquatic plant control, or shoreline straightening. A draft report will be presented at a public forum when completed. For more information, contact Mark Sesing (920) 485-3023.

# Invasive Species Tip

**Make a Habit of Cleaning Equipment** - The three main steps for cleaning boats, trailers and other equipment are: 1) remove all visible mud, plants, fish/animals; 2) eliminate water from all equipment before transporting anywhere; and 3) clean and dry anything that came in contact with the water.

Your equipment has many places where water can collect and harbor invasive species. Remove water from motors, jet drives, live wells, boat hulls, scuba gear, boots, waders, bait buckets, decoys, or floats. Cleaning can start with high-pressure water, but thorough cleaning for invasives will take hot (< 40° C or 104° F) or salt water (2/3rds cup salt for five gallons). Small equipment such as fishing line can be soaked in vinegar for 20 minutes or salt water for 24 hours. Finally, drying for at least five days before entering new waters will kill most aquatic invasive species.

**Special Note of Caution for Anglers** – Dispose of unwanted bait in the trash. Do not transfer bait or water from one water body to another. Larval zebra mussels or other invasive species could be present in the water with the bait.

# Winnebago Lakes Council Annual Report 2006

The idea for a citizens' lake organization to promote the sustainability of the Winnebago lakes originated in spring 2003 at a meeting hosted by the Oshkosh Area Community Foundation. Two years and many meetings later, the Winnebago Lakes Council was incorporated as a private, not for profit corporation. We are pleased to dedicate our first Annual Report to the many individuals, agencies and organizations that helped define our mission and continue to support our efforts to involve citizens in protecting and improving the ecological health and scenic beauty of the Winnebago lakes.

### **Organizational Development**

**Membership.** Membership grew from 30 to 160 members in 2006. Our goal is to triple membership by the end of 2007.

**Board of Directors**. Ten people served on our Interim Board. Eight of these members have agreed to stand for our first elected board. The new board will have at least 11 members representing a range of geographic areas and lake interests.

**Funding.** Support from community and agency advisors helped us obtain over \$60,000 in grants to fund our programs and part-time positions for a Program Assistant and an Aquatic Invasive Species Coordinator.

**Tax-Exempt Status.** Our application for a 501(c)(3) exemption was delayed eight months because the IRS was certifying numerous new non-profit organizations to deal with Hurricane Katrina disaster relief. With help from Senator Kohl's office, in June we qualified.

### **Community Education**

**Newsletter.** Our first step in building "a voice for our lakes" was to develop a logo and a quarterly newsletter *Waterways*. We distributed over 10,000 copies of our first four issues to area residents. Topics ranged from how water levels are set to what citizens can do to protect and improve the lakes.

**Events.** We held four events aimed at informing citizens and communities: February presentations in Winneconne on lake monitoring results; March presentations in Menasha with East Central Regional Planning on land use and water quality; a July picnic in Oshkosh with talks on aquatic invasive species, and an October panel in Oshkosh on the economic value of the fishery.

**Website.** In the construction stage is a web site to consolidate information about the lakes and allow interactive communication among lake users.

**Outreach.** Three presentations to area organizations, a story in *On the Water Magazine* and several newspaper articles reached thousands of area residents.

### **Programs and Projects**

**Citizen Lake Monitoring Network**. In cooperation with UWO and UWEX, we helped recruit over 100 citizen lake monitors who take Secchi disk readings to measure water clarity on all four lakes. Our goal is to improve communication among monitors as they increase the sophistication of their measuring tools.

**Aquatic Invasive Species Planning and Education**. Just beginning is a program to educate, plan and protect against invasive species in cooperation with UWO and UWEX. This summer a Clean Boats, Clean Waters project was initiated. An Aquatic Invasive Species Coordinator position is being filled.

**Network Building.** We are identifying local conservation organizations, civic groups, businesses, industries, agencies and governmental units to work together to develop and fund lake protection and improvement projects.
